Rhonda: Inquired about how quarantine will impact school progression through the year. Teachers are preparing students and lessons to be able to slide in and out of the different provincial scenarios.

Message from Ken Sampson was emailed to parents regarding positive test results.

Recently, Alberta Health Services (AHS) improved its methods for sending COVID-19 test results by relaying them via text message. This means that parents/guardians are often provided with this information well before the school or division.

As a result, we are asking that, if and when you learn of any positive test results in your home, please share this information with your child's school administration. This will allow us to follow up with AHS and provide notification to families as quickly as possible about the need to isolate.

We certainly recognize that this may be uncomfortable information to share. Rest assured that maintaining both your dignity and privacy is a responsibility that we take very seriously. Our aim is simply to reduce the spread of this disease and ensure the health and safety of our staff and students.

### **General Discussion:**

Ken Tratch asked how teachers/ school staff are coping given he COVID situation.

- Teachers are feeling a bit overwhelmed, it is different and teachers are feeling the weight of the situation.
- Teachers are concerned about the health parameters and student progress given the weight of trying to keep school as normal as possible.
- Teachers want to use best practice and are trying to do their best while balancing health restrictions.
- Meghan is encouraging parents to reach out to teachers to let them know about the positives they are seeing as teachers appreciate hearing the feedback.

Michelle inquired about COVID protocol in terms of having the schools shut down.

- Provincially it is a goal to not have schools shut down.
- Schools are trying to balance schedules and cohorts to minimize risk.
- Shutting down schools as was done in the spring is only a strong possibility if there is not enough staff to run the school.

Reports of fighting have occurred during times when there is less structure and there is concern about supervision.

- Meghan has asked for specific cases to speak with her directly.
- Labour laws restrict the number of supervisors available
