- 1. Call to Order --
- 2. Opening Prayer and Welcome Meghan Calder

- Move to approve by Deena, passed
- 4. Financial Report -
- Selestia met with Marina, provide a summary report at the end of each meeting
  - More open communication requested; some confusion regarding funds one point of contact (presumably treasurer)
- School engagement is still in account; Marina pulled it because the board will want it back at some point
- Have emailed Cobb's Bakery -- fine print says we have to have earned at least a \$25 profit to get anything, so we would like a summary of what we did make (we would have had to do at least \$250 and we have no idea how much we did)
- Mable's Labels should be on the way with a statement
  - Excellent website -- on there for next five years
  - At about \$90, which isn't bad considering it was end of year and we don't have to pay or do anything
- Starting balance: \$2041.33; estimated balance following bbq will be \$1356.33
- Karen has a note ready to go and we will try to get an estimate of people in attendance for the bbg
  - Note: lots of schools have gone to desserts instead of bbq
  - Has been a hit, but we have a resourceful council and have had no problem getting donations
  - Discussion of plan for bbq -- Meghan will speak, opening blessing, Caryn speaks to STEAM: Neuro Maker
- Selestia and Deena move to approve; financial report approved
- 5. New Business: Nominations and Elections
- New members needed -- we are not large enough to staff all positions

- We will leave positions open if needed in the hopes of recruiting new members at the September BBQ
- Note that a certain number of people are required for a quorum and at times we can't get enough people to meet that -- we need to educate parents about why we need them and what we do
- a) Chair Michelle allows her name to stand; uncontested: passed
- b) Vice Chair Deena allows her name to stand; uncontested: passed
- c) Treasurer No nominations deferred to next meeting
- d) Hot lunch/ Fundraising Coordinator Selesita allows her name to stand; uncontested: passed
- e) Secretary no nominations deferred to next meeting
- 6. Board Update Linda Ellefson
- Wonderful to have everyone at opening division mass and amazing how many people were attending their first in person divisional opening mass
- Linda is also a director for Alberta Public School Trustees and attended some rather long meetings in Edmonton recently and was able to connect with a representative from the Yukon
- Incredibly important to celebrate and promote Catholic public education because so few provinces still have it
- Question: will we always have to fight for Catholic education? Answer: Yes, always.
   Advocacy is the key to maintaining publicly funded Catholic education
- Question: Do we have dates for trustee meetings? Answer: Not yet. Believe meetings will be in person, but not sure
- Note: board meeting conflicts with back to school BBQ on Sept 28; accidental scheduling by the school
- 7. Principal Report
- Great start to the year
- New Canadian and ELL population is about 60 students, almost a third of students
  - 10 hour/week EA assigned to the school to provide small group support for English language learners
  - Meghan has scheduled Daphne to come the morning of the first PD day to discuss some of the countries our students are coming from
- As is typical, we lost thirty sixth graders and only brought in 19 kindergarten students, but we are stable: our projections were for 144 students and we are sitting at 166
  - Question re large class sizes -- staff discussed what we could provide with split classes and felt that, as we lost some teaching time, we could better serve students with a 0.5 literacy intervention teacher and by removing our associate principal from a homeroom teaching situation

- Question: did we receive a response to our letter addressing technology concerns?
   Answer: it has been acknowledged, but we haven't received a specific response yet
  - Meghan has made sure they are aware that allotments were based on projections and our actual numbers are somewhat higher
  - It hasn't made a difference in terms of funds as of yet, but we have a strong relationship with the IT department and they have been very helpful
- Question: will we be doing intramural teams? Answer: Yes, and we will revisit it throughout the year
- Question: will there be after school care this year? Answer: No, we didn't have sufficient interest. We have a few kindergarten students busing to St Mary's for after school care but that's it. We can try again next year but as of now there doesn't seem to be a need.
  - Note: busing has been a huge improvement this year

## 8. Teacher Report

- Caryn: the year is off to a great start and teachers are looking forward to the opening BBQ
- We have a new faith plan called Arise, Pilgrims of Hope! Caryn will speak to it further at the next meeting
- Our monthly focus will be taken from the agendas and used to help students, teachers, and parents consider our faith plan
